North Western Primary Health Network (NWMPHN) and the Royal Australian College of General Practitioners (RACGP) are offering free self-directed Aboriginal and Torres Strait Islander cultural awareness training to non-member general practices.

This is an opportunity to take advantage of a valuable training usually only offered <u>free to RACGP</u> members.

The training is a 6-hour online module covering Aboriginal and Torres Strait Islander culture and history. It is designed to enhance cultural awareness for practice staff, and thus improve health outcomes for patients. By participating in this training, your practice may be eligible to apply for the Australian Government's <u>Practice Incentives Program (PIP)</u> Indigenous Health Incentive.

Expressions of interest are now invited. Training is limited to 25 people.

Participants will:

- extend their knowledge about Aboriginal and Torres Strait Islander history and culture
- explore how attitudes and values can influence perceptions, assumptions, and behaviours in a clinical setting
- discuss key issues facing the practice team and Aboriginal and Torres Strait Islander people and consider ways to address them.

- complete all evaluation activities
- have access to a stable internet connection and relevant IT equipment.
